1. This event is being held in compliance with all provincial health and safety orders, as well as facility requirements for Covid-19.
2. Public Health requirements will be continuously evaluated, and participants will be informed of the Covid-19 protocols prior to the event through social media and email.
3. In the absence of any Public Health Order mandates, the organizing committee for SDCCS 2022 strongly encourage participants to:
 - a. Wear a mask for your own protection and the protection of others
 - b. Maintain physical distancing wherever possible
 - c. Frequent hand hygiene
 - d. Stay home if you feel sick
4. Upon registering for this event and immediately prior to the event, you agree to the requirements and recommendations of National, Provincial and local Public health and other governmental authorities and to those special safety regulations put in place by SDCCS 2022, ScotDance Canada and the Viterra International Trade Centre, as it pertains to the Covid-19 Coronavirus and to adopt all necessary measures to those effects.

GENERAL RULES AND REGULATIONS

5. All dancing events will be governed by the rules and regulations of the RSOBHD
6. Dancers will compete in reverse order of entry except for the Canadian Championships.
7. The decision of the judges is final.
8. Age is as of July 6, 2022 except for the Canadian Championship.
9. Age for the Canadian Championship is to be taken as of 12:01am July 1, 2022.
10. Any complaint made by an individual against the organization or adjudication of an event must be made in writing giving the complainants full name and address and shall be lodged with the organizer, if possible, on the day of the event and certainly not later than 48 hours after the event. Such complaint must be accompanied by a deposit of \$35. The deposit shall be returned should the complaint be upheld. If within seven days of lodging such complaint the complainant has received no satisfaction from the organizer, then the complainant may refer the matter to secretary@scotdance.ca.
11. Dancers must remain in full costume to receive awards and be present in group photo.
12. Dancers will retain the same status over the 4-day event.
13. Dancers will be required to fill in for Reels as required.
14. The Organizing Committee reserves the right to combine or divide age groups at their discretion.
15. Dancers reporting late for their dance may not be allowed to dance out of draw/numerical sequence.

16. Registration for all dancers and all events will begin on Wednesday, July 6, 2022. Dancers' numbers, schedules, pre-ordered social event tickets and souvenirs will be available at this time. For the remainder of the week, registration will be held for a limited time each day.
17. Dancers must present a valid RSOBHD dance registration card at time of registration.

RESTRICTED PREMIER RULES

18. For this event, a Restricted Premier dancer is defined as one who has not won an overall trophy in a Premier or Restricted Premier class for four years preceding the date of the Restricted Premier event that he/she is entering at SDCCS 2022 (from July 3, 2018 to July 6, 2022 inclusive). Provincial Representatives in the Canadian Championship may be eligible if this rule applies.
19. ScotDance Canada defines an OVERALL TROPHY win for Restricted Premier purposes as, "the dancer with the highest total number of points having competed in more than one (1) individual dance in a Premier competition age group that has 6 or more competitors, thus the name High Aggregate Trophy." Winners of special dances such as a Special Hornpipe or Special Jig, Best Dressed or Choreography event DO NOT qualify as an overall trophy win. A Championship and Pre-Championship are both considered a Premier event.
20. Dancers who meet the requirements for the Restricted Premier class must choose either Restricted Premier or Premier for the competitions on July 7 & 9, 2022, but not both (i.e. dancers may not compete in Premier and Restricted Premier on the same day).

PRE-CHAMPIONSHIP RULES

21. Pre-Championship is open to Premier dancers who have never won a Championship or Pre-Championship event. Provincial Representatives in the Canadian Championship may be eligible if this rule applies.
22. Premier and Restricted Premier dancers competing in the Under 12 years sections must choose to enter the Pre-Championship or the ScotDance Canada Open Championship on July 10, 2022; not both. Premier and Restricted Premier dancers competing in the 12 & over sections may choose to enter the Pre-Championship and/or the ScotDance Canada Open Championship on July 10, 2022.

GENERAL CHAMPIONSHIP RULES

23. These events have been sanctioned, and will be governed, by the rules and regulations of the Royal Scottish Official Board of Highland Dancing (RSOBHD)
24. The 2022 Championship Steps must be danced for the Canadian Championship and ScotDance Canada Open Championship.

CANADIAN CHAMPIONSHIP RULES

25. There will be a draw for order of dance for the Canadian Championship. This draw will take place after entries close and will be supervised by representatives of ScotDance Canada.
26. Provincial Representatives must be entered by their respective ScotDance Provincial Affiliate or Provincial Championship Organizer.

PREMIER SPECIAL EVENT RULES - BELLEGARDE BLUE BONNETS MEMORIAL

27. Open to all Premier and Restricted Premier dancers.
28. Dancers can choose their own steps, no set steps.

29. Preliminaries – Dancers will be split into age categories according to entries received to dance a 4 step Blue Bonnets. The top six dancers from each age category will advance to the finals.
30. Finals – The dancers who qualified from the Preliminaries will be split into 3 to 5 age categories (depending on entries) and dance a 4 step Blue Bonnets.
31. Special awards will be given to the top 6 finalists in each age category after the Finals.

CHOREOGRAPHY RULES

32. Premier and Pre-premier dancers may enter the solo and duet choreography events.
33. Entry Acceptance Date – April 6, 2022. No entries will be accepted prior to this date. Entries will be accepted online until June 6, 2022.
34. Average age determined based on the age of the dancer on July 6, 2022.
35. Each solo and duet entry must be submitted online, on the separate choreography entry form. Only one dancer is required to enter the duet and must list the name, age, date of birth and RSOBHD card number of their duet partner.
36. Rules as per RSOBHD.
37. Dancers will perform to their choice from a list of predetermined music. Predetermined tracks of music will be between 1.5 and 2 minutes.
38. Predetermined music list will be published online March 15, 2022 and will be available via email upon request. Contact SDCCS2022music@gmail.com
39. Choice of music track must be submitted online at the time of entry.
40. Dancers may enter one solo and one duet provided that different tracks of music are chosen for each event.
41. Teams may use props during their performance, either static or non-static provided that they do not require set-up or take-down, but live animals are not permitted.

Rules 42-44 are set rules for annual awards.

IRENE BAIRD BEST OVERSEAS DANCER TROPHY RULES

42. The Irene Baird Best Overseas Dancer Trophy is awarded to the Premier dancer who permanently resides outside of North America who accumulates the most points overall in the ScotDance Canada Championship Series events, excluding the Choreography and Special Events. Should a dancer enter two competitions on the same day, e.g. the Pre-Championship and the ScotDance Canada Open Championship, only the results from the dancer's most successful competition will be used in the calculation towards the Best Overseas Dancer Trophy.

ALEX AND MAY MARTIN TROPHY RULES

43. The Introduced in 1995, the Alex and May Martin Trophy is awarded annually to the Premier dancer who permanently resides in North America and accumulates the most points overall in the ScotDance Canada Championship Series events, excluding the Canadian Championship, Choreography, and Special Events. Should a dancer enter two competitions on the same day, e.g. the Pre-Championship and the ScotDance Canada Open Championship, only the results from the dancer's most successful competition will be used in the calculation towards the Alex and May Martin Trophy.

ADELINE DUNCAN DANCER OF THE DAY RULES

44. The Adeline Duncan Dancer of the Day Trophy will be awarded to the dancer who accumulates the most championship dance points over all age groups in the Canadian Championship. In the event of a tie, RSOBHD Championship scrutineering rules will apply.

GENERAL AUDIENCE SEATING AREA RULES

45. Limit of 1 small bag per person. No large dance bags or garment bags will be permitted.
46. In accordance with the ScotDance Canada Risk Management Policies, dancers must not change costumes in public view or in public washrooms. Dancers must use the provided secured changing facilities ONLY. Dancers in violation of this policy will be asked to leave the area until properly dressed and will have their names forwarded to the Risk Management Committee of ScotDance Canada where further action may be taken.
47. Placing bags or clothing on seats will not be permitted.
48. No dance mats or boards permitted outside of the designated warm-up area. No warming up in the seating area.
49. No parents are allowed behind the stage area. Only professionals and volunteers with proper accreditation will be permitted access.
50. Videotaping will be permitted in designated areas only.
